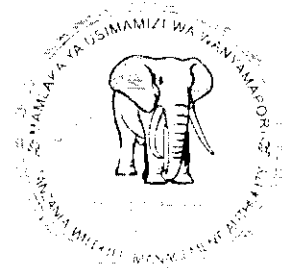

The Government of the United Republic of Tanzania has set aside funds for the operation of the **Drilling and hand pump installation for 9 villages in Masasi District Council (Mapili, Chikolopola, Mkachima, Manyuli, Lichehe, Geuza, Maparawe, Sindano & Mbangala)** during the financial year 2017-2018. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for Drilling and hand pump installation for 9 villages in Masasi District council.

A complete set of Tendering Document(s) in *English* and additional sets may be purchased by interested Tenderers on the submission of a written application to the address given under paragraph 4 above and upon payment of a non-refundable fee of Tsh 50,000 (fifty thousand only) Payment should either be by Cash, Banker's Draft, or Banker's Cheque, payable to **Masasi District Council**.
6. All Tenders must be accompanied by a Tender securing declaration in the format provided in the Tendering documents unless otherwise stated in the Tender Data Sheet.
